Bank Reconciliation

Reconciling the bank statements is a very important part of the accounting/bookkeeping process. Monthly, quarterly, or yearly financial reports should **never** be presented to the church board until **all** bank accounts have been reconciled in your PowerChurch Software.

In this newsletter, we will be going through the bank reconciliation process in PowerChurch. I will be sharing some helpful tricks I use to make the bank reconciliation easier and even fun!

As long as you reconcile the bank statements manually, is it ok to not reconcile them in PowerChurch? The answer is a definite NO!

When you are printing the financial reports, you give to the church board out of your PowerChurch Accounting Software, reconciling the bank statements within that same accounting software is a **crucial** part of preparing your financial reports. Why?

- ➤ You will know that all checks, deposits, service charges, and interest earned, etc. are included your financial reports. In other words, all entries connected to each bank account were entered and posted correctly in PowerChurch.
 - We have worked with many church bookkeepers who did not realize the importance of the bank reconciliation process. By the time the church bookkeeper came to us for help, considerable time was needed to get their financial records in order.
- If you have only reconciled your bank statements manually, you cannot know your financial reports are reflecting the correct balance in your banking accounts or your income and expense reports.
 - If the bank balance is not correct in PowerChurch, then 99% of the time there are also errors in the reported income and expense lines.
- Again, the bank reconciliation process is a **crucial** part of preparing your financial reports.

Reconciling bank accounts in PowerChurch can be a relatively easy process. Using a good and consistent routine in the reconciliation process is the key to making the bank reconciliation accurate.

Are you ready? Below is the process we use to reconcile bank statements in PowerChurch.

Reconciling Bank Accounts in PowerChurch

- A. Look at your bank statement. Is there any interest earned or are there service charges that you know have not yet been entered in PowerChurch? Go ahead and make those entries.
 - 1. Interest earned Debit your bank account

Credit an income such as "Bank Interest"

2. Service charges - Credit your bank account

Debit an expense such as "Bank Fees"

- 3. Note: Your bank statement will show the debits and credits opposite of the debits and credits in PowerChurch. Why? The bank's debits and credits are *their* side of the books. The PowerChurch debits and credits are *your* side of the books. That is why they are opposite. Don't let that throw you! Just remember that if an amount is a debit on the bank statement, it will be a credit in PowerChurch. If the amount is a credit on the bank statement, it will be a debit in PowerChurch.
- B. Print the *unreconciled* check register from PowerChurch.
 - 1. Choose a date range that will include every amount that has not yet been reconciled thru the end of the month you are reconciling.
 - In this case, we are reconciling January 2016 and *Dates from* 12/01/2015 to 01/31/2016 will catch all that has not yet been reconciled.
 - After you print the check register, check the last page to make sure there is no note at the bottom of the report stating you have unreconciled items previous to the date range chosen for your report.
 - 2. You will be using this report as a working paper to help you reconcile your bank.
 - 3. To print this check register, click on:

Accounting > Fund Accounting > Reports Fund Accounting > Check Register

C. Place the check register beside your bank statement. You will need a highlighter pen – yellow is suggested.

- 1. Find an item and amount on your bank statement, then find the same item and amount on your check register.
- 2. Highlight them both.
- 3. Your goal is to match every debit and credit item on your bank statement with an opposite debit and credit on your check register.
- 4. If you have items on your bank statement that you have not highlighted:
 - There may be entries that need to be made in PowerChurch
 - It may also be possible you have made the entries but not posted them, or have coded them incorrectly
 - Note: If any additional entries are made, you will need to hand write them on your check register so they can be highlighted if needed to match with the bank statement.
- D. Once you have highlighted all the matching debit and credit items on the bank statement to your check register:
 - 1. Look at all the items on your check register that were not highlighted.
 - Do they make sense as being truly outstanding?
 - If for example, you have a contribution from the beginning of the month you are reconciling that is not highlighted, you need to find out why that deposit did not make it to the bank.
 - If you have a check that is still outstanding and is dated from 2 or more months ago, we suggest you contact the person to whom the check was made. They may have lost the check or just forgotten they had it. Don't let old outstanding checks hang around.
 - Don't let any old outstanding amount hang around. If any item is old and unreconciled, investigate to determine the proper action needed to be able to reconcile that item.
- E. Once you are confident your highlighted check register is complete, you are ready to reconcile your bank statement in PowerChurch. Click on:

Accounting > Fund Accounting > Reconcile Bank/Credit Card Accounts

- F. Choose the *Account to reconcile*. Clicking on the magnifying glass will give you a list from which to choose.
 - 1. Enter the ending bank balance <u>not</u> the beginning balance.
 - 2. Click next.

- **G.** Every item you had highlighted on your check register needs to be cleared on the PowerChurch bank reconciliation screen. To clear an item:
 - 1. Click on the line that needs to be cleared
 - Note the debits are in the top section and credits are in the bottom section.
 - 2. The line will now be highlighted.
 - **3.** Press the enter key on your keyboard to clear the line. Notice there is a "C" to the left of that line.
 - 4. To un-clear a line, click on a line and press enter again to un-clear the line.
 - 5. Your goal is have 0.00 in *To Balance*. If you are not getting the amount of 0.00:
 - DO NOT click Done
 - Instead, compare the items on the bank reconciliation screen and your check register to see if you can determine the reason for the imbalance.
 - If you need to exit the bank reconciliation screen before you have a *To* balance of 0.00. Click on: *Postpone*.
 - When you come back into the bank reconciliation later, your work has been saved. Once the *To balance* amount is 0.00, click *Done*.
 - Note: DO NOT click to Done until To Balance is 0.00.

Congratulations, you have reconciled your bank statement with PowerChurch! We suggest you staple the following together:

- 1. On top of the stack of papers is the bank reconciliation report printed from PowerChurch
- 2. Next is the bank statement from the bank
- 3. Last is the highlighted check register used as your work paper
- 4. This gives a very nice hard copy backup to your bank reconciliation work

Repeat the process for any bank account your church has. This includes:

- Savings accounts
- PayPal account
- CDs
- Investments
